Rick **verified notices** had been posted at the Juda Post Office, the Juda Community Center, and the Recycling Center. A notice was also published on the Town of Jefferson's website.

The **annual report** was reviewed and discussed with Kurt making a motion to approve. Nathan seconded and the motion carried.

The **annual meeting was adjourned** on a motion by Nathan and a second by Kurt. Motion carried.

APRIL TOWN BOARD MEETING

The regular monthly meeting of the Town of Jefferson was **called to order** at 6:15pm on April 21, 2026, at the Juda Community Center. In attendance were Rick Nusbaum, Kurt Jordan, Amy McCullough, Nathan Weber, Joe Jones, and Brian McKeon.

Rick **verified notices** had been posted at the Juda Post Office, the Juda Community Center, and the Recycling Center. A notice was also published on the Town of Jefferson's website.

For **public input**, it was reported that the bridge on Blumer Road was washed out behind the wing wall.

The **clerk's report** was reviewed with Kurt making a motion to accept. Nathan seconded, and the motion carried. In other correspondence:

- The floors at the community center will be deep cleaned/waxed in May.
- Pride Day is May 15. Students will come down and clean up around the outside of the community center and plant flowers in front of the fire station.
- Open Book will be held on May 19 from 2-4pm and Board of Review will be held on May 28 from 6-8pm.

The **treasurer's report** was reviewed, noting cash on hand as of March 31, 2026, at \$293,987.68. Nathan made a motion and Kurt seconded to accept the treasurer's report. Motion carried.

There will be a **planning commission** meeting on May 5, 2026, at 6pm to discuss two land division requests and to discuss data centers.

For **road maintenance**, a discussion was held regarding the roads that will be repaired within the township by the Green County Highway Department/Scott Construction in 2026. There will be a culvert ordered for the bridge just south of Twin Grove. Joe has been trimming trees and will be shouldering to fix washouts. There were no **driveway permits**.

The bills were circulated to board members with Kurt making a motion and Nathan seconding to accept **payment of bills**. Motion carried.

The **next meeting** will be held on May 13, 2026.

The meeting was **adjourned** on a motion by Kurt and a second by Nathan. Motion carried.
